#### **Definitions**

For this Privacy & POPIA Policy, the following definitions apply:

Cookies are small files that are placed on your computer, mobile device, or any other device by a website, containing the details of your browsing history on that website among its many uses.

The country refers to South Africa.

Device means any device that can access the internet or our website, such as a computer, a cellphone, or a digital tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service Provider means any natural or legal person who processes the data on behalf of IGNIS Forensic Fire Investigation and Prevention Pty Ltd. It refers to third-party companies or individuals employed by IGNIS Forensic Fire Investigation and Prevention Pty Ltd to facilitate our website, and our products and services, to provide our website on behalf of IGNIS Forensic Fire Investigation and Prevention Pty Ltd, to perform services related to our website and our products and services, or to assist IGNIS Forensic Fire Investigation and Prevention Pty Ltd in analyzing how our website is used.

This Privacy & POPIA Policy describes our policies and procedures on the collection, use, and disclosure of your information when you use our website and keeps you informed about your privacy rights and how the law protects you and your personal information. We use your personal data to provide and improve your experience on our website. By using our website, you agree to the collection and use of information per this Privacy & POPIA Policy.

## The Information We Collect

We collect and process your personal information mainly to contact you to understand your requirements and deliver services accordingly. For this purpose, we will collect contact details including your name and organization.

We collect information directly from you and you provide us with your personal details. Where possible, we will inform you what information you are required to provide to us and what information is optional.

Website usage information may be collected using "cookies" which allows us to collect standard internet visitor usage information.

#### **Personal Data**

While using our website or setting you up as a client for purchase purposes, we may ask you to provide us with certain personal information that can be used to contact you.

By submitting your information to us, you acknowledge that any information you provide is, per the POPI Act, voluntary, specific, and informed. Personal information may include, but is not limited to:

- Your email address
- Your first name and last name
- Your phone number
- Your business VAT Number
- Your business address

If you do not wish to provide your personal information, we cannot provide you with ideal product and service conditions.

## **Usage Data**

Usage Data is collected automatically when using our website or any other website.

Usage Data may include information such as your device's Internet Protocol address (your IP address), browser type, browser version, the pages of our website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

We may also collect information that your browser sends whenever you visit our website or when you access our website via a mobile device.

# Cookies

A cookie is a small file stored on your device. We use Cookies and similar tracking technologies to track the activity on our website and store certain information. Tracking technologies are beacons, tags, and scripts that collect and track information, to improve your usage of our website.

You can instruct your browser to refuse all Cookies or to indicate when a cookie is being sent. However, if you do not accept Cookies, you may not be able to use some parts of our website.

Unless you have adjusted your browser setting so that it will refuse cookies, our website will make use of Cookies.

#### Your Personal Data

IGNIS Forensic Fire Investigation and Prevention Pty Ltd may use your Personal Data for the following purposes:

To provide and maintain our website including monitoring the usage of our website pages.

# For other purposes

We may use your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns, and evaluating and improving our website, products, services, marketing, and your experience.

We may share your personal information in the abovementioned situations: our organization will not divulge your personal data or information without your consent and without valid reasons.

#### **Retention of Your Personal Data**

IGNIS Forensic Fire Investigation and Prevention Pty Ltd will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy & POPIA Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

IGNIS Forensic Fire Investigation and Prevention Pty Ltd will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period; except when this data is used to strengthen the security or to improve the functionality of our website, or we are legally obligated to retain this data for longer time periods.

Otherwise, we will retain and collect your data:

- To gather contact information
- To confirm and verify your identity or to verify that you are an authorised user for security purposes
- For the detection and prevention of fraud, crime, money laundering, or other malpractice
- To conduct market or customer satisfaction research or statistical analysis
- For audit, tax, and record-keeping purposes
- In connection with legal proceedings

#### **Transfer of Your Personal Data**

Your information, including Personal Data, is processed at IGNIS Forensic Fire Investigation and Prevention Pty Ltd website hosts' offices. This means that this information may be transferred to —

#### **Disclosure of Your Personal Data**

We may disclose your personal information to our service providers who are involved in the delivery of products or services to you. We have agreements in place to ensure that they comply with the privacy requirements as required by the Protection of Personal Information Act.

We may also disclose your information where and when we have a duty or a right to disclose in terms of law or industry codes or where we believe it is necessary to protect our rights.

#### **Business Transactions**

If IGNIS Forensic Fire Investigation and Prevention Pty Ltd is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy & POPIA Policy.

#### Law enforcement

Under certain circumstances, IGNIS Forensic Fire Investigation and Prevention Pty Ltd may be required to disclose your personal data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

# Other legal requirements

The IGNIS Forensic Fire Investigation and Prevention Pty Ltd may disclose your personal data in the good faith belief that such action is necessary to:

- Comply with a legal obligation
